ORDINANCE NO. 2024.09.10A

AN ORDINANCE APPROVING AND ADOPTING THE VILLAGE OF SURFSIDE BEACH, TEXAS, GENERAL BUDGET FOR THE 2024-2025 FISCAL YEAR; MAKING APPROPRIATIONS FOR THE VILLAGE FOR SUCH YEAR AS REFLECTED IN SAID BUDGET; ESTABLISHING THE PROCEDURE FOR INTRA-BUDGET TRANSFERS; AND CONTAINING OTHER PROVISIONS RELATING TO THE SUBJECT.

WHEREAS, within the time and in the manner required by law, the City Council considered a proposed General Budget of expenditures of the Village of Surfside Beach, Texas, for the City's 2024-2025 fiscal year; and

WHEREAS, pursuant to a motion of the City Council and after notice required by law, the required public hearings on such General Budget were held at the City Hall, 1304 Monument Drive, Surfside Beach, Texas, 77541, at which hearings all citizens and taxpayers of the Village had the right to be present and to be heard and those who requested to be heard were heard; and

WHEREAS, the City Council has considered the proposed General Budget and has made such changes therein as in its judgment were warranted by law and were in the best interest of the citizens and taxpayers of the Village; and

WHEREAS, a copy of such General Budget has been filed with the City Secretary and the City Council now desires to approve and adopt the same;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE VILLAGE OF SURFSIDE BEACH, TEXAS:

Section 1. The facts and matters set forth in the preamble of this Ordinance are hereby found to be true and correct.

Section 2. The City Council hereby approves and adopts the General Budget described in the preamble of this Ordinance, a copy of which is attached hereto and made a part of this Ordinance for all purposes and a copy of which is on file with the City Secretary. The City Secretary is hereby directed to place on said budget an endorsement, which shall be signed by the City Secretary, which shall read as follows:

"The Original General Budget of the Village of Surfside Beach, Texas, for the 2024-2025 Fiscal Year."

Such budget, as thus endorsed, shall be kept on file in the office of the City Secretary as a public record.

<u>Section 3</u>. In support of said budget and by virtue of the adoption thereof, including any and all changes adopted thereto, the several amounts specified for the various purposes named in said budget are hereby appropriated to and for such purposes.

Section 4. The City Council takes cognizance of the fact that in order to facilitate operations of the Village and its various departments and activities and to make adjustments occasioned by events transpiring during the year, some transfers may be necessary to and from some accounts contained within the budget as originally adopted. Accordingly, should the Mayor from time to time determine that transfers are necessary from unexpended funds in one or more budget accounts to another budget account, and the same may be accomplished without creating a deficit in the requirements of any City Department or activity, he shall recommend such transfers to the City Council. Upon approval thereof by the City Council, an amendment sheet reflecting such transfer or transfers shall be attached to the budget as specifically adopted, whereupon the City Council shall treat such funds as if they had been thus budgeted in the first instance.

ORDINANCE NO. 2024-09-10B

AN ORDINANCE OF THE VILLAGE OF SURFSIDE BEACH, TEXAS, PROVIDING FOR THE ASSESSMENT, LEVY, AND COLLECTION OF AD VALOREM TAXES OF THE VILLAGE OF SURFSIDE, TEXAS, FOR THE YEAR 2024 AND FOR EACH YEAR THEREAFTER UNTIL OTHERWISE PROVIDED; PROVIDING THE DATE ON WHICH SUCH TAXES SHALL BE DUE AND PAYABLE; PROVIDING FOR PENALTY AND INTEREST ON ALL TAXES NOT TIMELY PAID; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

WHEREAS, Section 26.05 of the Texas Tax Code provides that by September 30, or the 60th day after the date the certified appraisal roll is received by the City, whichever is later, the governing body of each taxing unit shall adopt a tax rate for the current tax year; and

*

WHEREAS, such Section further provides that where the tax rate consists of two components (one which will impose the amount of taxes needed to pay the City's debt service and the other which will impose the amount of taxes needed to fund maintenance and operation expenditures of the City for the next year), each of which two components must be approved separately; and

WHEREAS, THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE; and

WHEREAS, THE TAX RATE WILL EFFECTIVELY BE RAISED 3.50 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$-1.99; and

WHEREAS, the proposed tax rate for the current tax year of the Village of Surfside Beach, Texas, consists of two such components, \$0.030719 for Interest and Sinking Rate (Debt Service Fund), and a tax rate of \$0.24848 on each *one hundred dollars* (\$100) of assessed valuation to fund maintenance and operation expenditures; and

WHEREAS, by separate motions heretofore adopted by the City Council of the Village of Surfside Beach, Texas, at a meeting of said City Council held on this 10th day of September, 2024, said City Council has approved separately the tax rate heretofore specified for each of said components; and

WHEREAS, having thus separately approved the tax rate for each of such components, it is necessary and appropriate for the City Council to now formally pass, approve, and adopt a 2024 tax rate ordinance for the Village of Surfside Beach, Texas; and

WHEREAS, all notices and hearings required by law as a prerequisite to the passage, approval, and adoption of said tax rate ordinance have been timely and properly given and held;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE VILLAGE OF SURFSIDE BEACH, TEXAS

<u>Section 1.</u> The facts and matters set forth in the preamble of this Ordinance are hereby found to be true and correct, and are hereby adopted, ratified, and confirmed.

<u>Section 2.</u> All property subject to ad valorem taxation by the Village of Surfside Beach, Texas, shall be equally and uniformly assessed for such purposes at *one hundred percent* (100%) of the fair market value of such property.

Section 3. There is hereby levied for general purposes and use by the Village of Surfside Beach, Texas, for the year 2024, and for each year thereafter until otherwise provided, an ad valorem tax at the rate of \$0.24848 on each *one hundred dollars* (\$100) of assessed valuation on all property, real, personal, and mixed, within the corporate limits upon which an ad valorem tax is authorized by law to be levied by the Village of Surfside Beach, Texas. The proceeds from such tax shall be applied to the payment of the general and current expenses of the government of the City. All such taxes shall be assessed and collected in current money of the United States of America.

Section 4. For the purpose of paying the interest on bonds, warrants, certificates of obligation, or other lawfully authorized evidence of indebtedness issued by the Village of Surfside Beach, Texas, including the various installments of principal due on the serial bonds, warrants, certificates of obligation, or other lawfully authorized evidence of indebtedness issued by the Village as such installments shall respectively mature, and for the purpose of repaying any sums borrowed in anticipation of current revenues for use in the payment of bonds and certificates of obligation and interest thereon maturing in the fiscal year 2024-2025, and for the purpose of paying interest and making provisions for the sinking fund on such other bond issues, warrants, certificates of obligation, or other lawfully authorized evidence of indebtedness as may be authorized, there is hereby levied for the year 2024 and for each year thereafter until otherwise provided, to be assessed and collected upon all property described in Section 3 of this Ordinance, an annual ad valorem tax at the rate of (\$0.030719) on each *one hundred dollars* (\$100) of assessed valuation.

Section 5. All ad valorem taxes levied hereby, in the total amount of (\$0.24848) on each *one hundred dollars* (\$100) of assessed valuation, as reflected by Sections 3 and 4 hereof, shall be due and payable on or before January 31, 2025. All ad valorem taxes due the Village of Surfside, Texas, and not paid on or before January 31 following the year for which they were levied shall bear penalty and interest as prescribed in the Property Tax Code of the State of Texas.

<u>Section 6.</u> All ordinances or parts of ordinances inconsistent or in conflict herewith are, to the extent of such inconsistency or conflict, hereby repealed.

Current expenses - \$280 cleaning for upstairs after all indoor rentals, water, pest control, Wi-Fi, electric, garbage, alarm monitoring, septic maintenance, and regular building maintenance.

Rental rate increase proposition-

It is my recommendation that the rental rate increase to \$1200.00 +\$200 deposit for a total of \$1400.00 a day every day no matter the day of the week for the Upstairs/Downstairs Combo. Upstairs only should increase to \$1100.00 + \$200 deposit for a total of \$1300.00 a day every day no matter the day of the week. And downstairs only can remain the same at \$250 + \$100 deposit as no amenities have been added or upgraded.
